#### Grounds for Annulment

In order for an annulment to be pursued there are certain situations that are considered grounds for annulment. They include:

• One or both spouses are were impaired through the use of alcohol or drugswhen

- they got married
- The husband, wife or both were already a registered domestic partner of someone else, or they were married to someone else during the time the marriage occurred
- The marriage is the result of an *incestuous relationship* both are one of the spouses was not of legal age to marry at the time of the marriage
- One of the spouses defrauded the other and it resulted in the marriage
- One of the parties was forced into the marriage
- One of the parties was physically or mentally incapacitated

#### How to Get an Annulment

Getting an annulment isn't something that that can be taken lightly, and it is not something you should consider trying to take care of on your own. A good family law or divorce attorney understands how to annul a marriage because they understand how to build a strong enough case to compel a judge to get one granted.

In regards to the annulment time frame, they can take as little as four to six weeks. They can also take as long as a few months to a year depending on how complicated your case is.
