Discovery

Children

If there are children involved, the correct forms have to be filed with the nearest child support agency.

Hearings

There might be pre-trial hearings as well as a final trial to await any final decisions if required.

After all of this is done, the judge will issue his or her final decisions regarding the divorce. In some cases, the two legal teams might try to get together to reach a final settlement before going to trial. This can save a lot of time and money.

After a Divorce

Once the divorce process has finished, one or both spouses might try to appeal or modify the divorce decree. This is an appeal that has to be issued with respect to a decision that has been entered by a judge. In this case, the appeal will go to an appellate court, also known as an appeals court.
